

Complexity of Cocktail Party Graph and Crown Graph

Abstract Problem statement: The number of spanning trees $\tau(G)$ in graphs (networks) was an important invariant. **Approach:** Using the properties of the Chebyshev polynomials of the second kind and the linear algebra techniques to evaluate the associated determinants. **Results:** The complexity, number of spanning trees, of the cocktail party graph on $2n$ vertices, given in detail in the text was proved. Also the complexity of the crown graph on $2n$ vertices was shown to have the value $n^{n-2} (n-1) (n-2)^{n-1}$. **Conclusion:** The number of spanning trees $\tau(G)$ in graphs (networks) is an important invariant. The evaluation of this number and analyzing its behavior is not only interesting from a mathematical (computational) perspective, but also, it is an important measure of reliability of a network and designing electrical circuits. Some computationally hard problems such as the travelling salesman problem can be solved approximately by using spanning trees. Due to the high dependence of the network design and reliability on the graph theory we introduced the above important theorems and lemmas and their proofs.

Key words: Complexity of graphs, spanning trees, cocktail party graphs, chebyshev polynomials, crown graph

INTRODUCTION

In this introduction we give some basic definitions and lemmas. We deal with simple and finite undirected graphs $G = (V, E)$, where V is the vertex set and E is the edge set. For a graph G , a spanning tree in G is a tree which has the same vertex set as G . The number of spanning trees in G , also called, the complexity of the graph, denoted by $\tau(G)$, is a well-studied quantity (for long time). A classical result of Kirchhoff (1847) can be used to determine the number of spanning trees for $G = (V, E)$. Let $V = \{v_1, v_2, \dots, v_n\}$, then the Kirchhoff matrix H defined as $n \times n$ characteristic matrix $H = D - A$, where D is the diagonal matrix of the degrees of G and A is the adjacency matrix of G , $H = [a_{ij}]$ defined as follows: (i) $a_{ij} = -1$ when v_i and v_j are adjacent and $i \neq j$, (ii) a_{ij} equals the degree of vertex v_i if $i = j$ and (iii) $a_{ij} = 0$ otherwise. All of co-factors of H are equal to $\tau(G)$. There are other methods for calculating $\tau(G)$. Let $\mu_1 \geq \mu_2 \geq \dots \geq \mu_p$ denote the eigenvalues of H matrix of a p point graph. Then it is easily shown that $\mu_p = 0$. Furthermore, Kelmans and Chelnokov (1974) shown that, $\tau(G) = \frac{1}{p} \prod_{k=1}^{p-1} \mu_k$. The formula for the number of

spanning trees in a d -regular graph G can be expressed as $\tau(G) = \frac{1}{p} \prod_{k=1}^{p-1} (d - \mu_k)$ where $\lambda_0 = \lambda_1, \lambda_2, \dots, \lambda_{p-1}$ are the

eigenvalues of the corresponding adjacency matrix of the graph. However, for a few special families of graphs there exist simple formulas that make it much easier to calculate and determine the number of corresponding spanning trees especially when these numbers are very large. One of the first such result is due to Cayley (1889) who showed that complete graph on n vertices, K_n has n^{n-2} spanning trees that he showed $\tau(K_n) = n^{n-2}$, $n \geq 2$. Another result, $\tau(K_{p,q}) = p^{q-1} q^{p-1}$, $p, q \geq 1$, where $K_{p,q}$ is the complete bipartite graph with bipartite sets containing P and q vertices, respectively. It is well known, as in e.g.,

(Clark, 2003; Qiao and Chen, 2009). Another result is due to Guy (1970) who derived a formula for the wheel on $n+1$ vertices, W_{n+1} , which is formed from a cycle C_n on n vertices by adding a vertex adjacent to every vertex of C_n . In particular, he showed that

$$\tau(W_{n+1}) = \left(\frac{3+\sqrt{5}}{2}\right)^n + \left(\frac{3-\sqrt{5}}{2}\right)^n - 2, \text{ for } n \geq 3.$$

Sedlacek (1970) also later derived a formula for the number of spanning trees in a Mobius ladder. The Mobius ladder M_n is formed from cycle C_{2n} on $2n$ vertices labeled $v_1,$

v_2, \dots, v_{2n} by adding edge $v_i v_{i+n}$ for every vertex v_i where $i \leq n$. The number of spanning trees in M_n is given by $\tau(M_n) = \frac{n}{2} [(2 + \sqrt{3})^n + (2 - \sqrt{3})^n + 2]$ for $n \geq 2$. Another class of graphs for which an explicit formula has been derived is based on a prism (Boesch and Bogdanowicz, 1987; Boesch and Prodinger, 1986). Let the vertices of two disjoint and length cycles be labeled v_1, v_2, \dots, v_n in one cycle and w_1, w_2, \dots, w_n in the other. The prism R_n is defined as the graph obtained by adding to these two cycles all edges of the form $v_i w_i$. The number of spanning trees in R_n is given by the following formula $\frac{n}{2} [(2 + \sqrt{3})^n + (2 - \sqrt{3})^n - 2]$.

Lemma 1.1: Temperley (1964):

$$\tau(G) = \frac{1}{p^2} \det(H + J)$$

where, J is the $p \times p$ matrix, where all elements are unity. We can also deduce the following lemma.

Lemma 1.2: $\tau(G) = \frac{1}{p^2} \det(pI - \bar{D} + \bar{A})$ where \bar{A} , \bar{D} are the adjacency and degree matrices of \bar{G} , the complement of G , respectively and I is the $p \times p$ unit matrix.

The advantage of these formulas in lemma 1.1, lemma 1.2 is to express $\tau(G)$ directly as a determinant rather than in terms of cofactors as in Kirchhoff theorem or eigenvalues as in Kelmans and Chelnokov formula.

Proof lemma 1.2: Since $\tau(G) = \frac{1}{p^2} \det(H + J)$, $H = D - A$ then $D = H + A$, since $D + \bar{D} = (p - 1)I$, then $D = (p - 1)I - \bar{D}$. Thus $H + A = (p - 1)I - \bar{D}$, since $J - A = I + \bar{A}$. By addition we get $H + J = pI - \bar{D} + \bar{A}$ and therefore $\tau(G) = \frac{1}{p^2} \det(pI - \bar{D} + \bar{A})$.

In our computations we need some lemmas on determinants and some relations concerning Chebyshev polynomials. We begin from their definitions, Zhang et al. (2005).

Let $A_n(x)$ be $n \times n$ matrix such that:

$$A_n(x) = \begin{pmatrix} 2x & -1 & 0 & & \\ -1 & 2x & -1 & 0 & \\ 0 & \ddots & \ddots & \ddots & \\ & \ddots & \ddots & \ddots & -1 \\ & & 0 & -1 & 2x \end{pmatrix}$$

where all other elements are zeros.

Further we recall that the Chebyshev polynomials of the first kind are defined by Eq. 1:

$$T_n(x) = \cos(n \arccos x) \tag{1}$$

The Chebyshev polynomials of the second kind are defined by Eq. 2:

$$U_{n-1}(x) = \frac{1}{n} \frac{d}{dx} T_n(x) = \frac{\sin(n \arccos x)}{\sin(\arccos x)} \tag{2}$$

It is easily verified that Eq. 3:

$$U_n(x) - 2xU_{n-1}(x) + U_{n-2}(x) = 0 \tag{3}$$

It can then be shown from this recursion that by expanding $\det A_n(x)$ one gets Eq. 4:

$$U_n(x) = \det(A_n(x)), n \geq 1 \tag{4}$$

Furthermore by using standard methods for solving the recursion (3), one obtains the explicit formula Eq. 5:

$$U_n(x) = \frac{1}{2\sqrt{x^2 - 1}} [(x + \sqrt{x^2 - 1})^{n+1} - (x - \sqrt{x^2 - 1})^{n+1}], n \geq 1 \tag{5}$$

where the identity is true for all complex x (except at $x = \pm 1$ where the function can be taken as the limit).

Lemma 1.3: Let $B_n(x)$ be $n \times n$ matrix such that:

$$B_n(x) = \begin{pmatrix} x & -1 & 0 & & \\ -1 & 1+x & -1 & 0 & \\ 0 & -1 & 1+x & -1 & \ddots \\ & \ddots & \ddots & \ddots & \ddots & 0 \\ & & \ddots & -1 & 1+x & -1 \\ & & & 0 & -1 & x \end{pmatrix}$$

Then one can obtain:

$$\det(B_n(x)) = (x - 1)U_{n-1}\left(\frac{1+x}{2}\right)$$

Proof: Straightforward induction using properties of determinants and above mentioned definition.

Lemma 1.4: Let $C_n(x)$ be $n \times n$ matrix, $n \geq 3$, $x > 2$ then:

$$\begin{aligned} & \times \det \begin{pmatrix} n+2 & 0 & 1 & \dots & 1 \\ 0 & n+3 & 0 & \ddots & \vdots \\ 1 & 0 & \ddots & \ddots & 1 \\ \vdots & \ddots & \ddots & n+3 & 0 \\ 1 & \dots & 1 & 0 & n+2 \end{pmatrix} \\ & = \frac{1}{(2n)^2} \frac{2n-2}{n-2} \det \begin{pmatrix} n-1 & -1 & 0 & \dots & 0 \\ -1 & n & -1 & \ddots & \vdots \\ 0 & -1 & \ddots & \ddots & 0 \\ \vdots & \ddots & \ddots & n & -1 \\ 0 & \dots & 0 & -1 & n-1 \end{pmatrix} \\ & \times 2 \det \begin{pmatrix} n+1 & -1 & 0 & \dots & 0 \\ -1 & n+2 & -1 & \ddots & \vdots \\ 0 & -1 & \ddots & \ddots & 0 \\ \vdots & \ddots & \ddots & n+2 & -1 \\ 0 & \dots & 0 & -1 & n+1 \end{pmatrix} \\ & = \frac{1}{(2n)^2} \frac{2n-2}{n-2} [(n-2)U_{n-1}(\frac{n}{2})][2nU_{n-1}(\frac{n+2}{2})] \\ & = \frac{1}{(2n)^2} \times \frac{2(n-1)}{n-2} \times (n-2) \frac{1}{2^n \sqrt{n^2-4}} \\ & [(n+\sqrt{n^2-4})^n - (n-\sqrt{n^2-4})^n] \\ & \quad \times 2n \frac{1}{2^n \sqrt{(n+2)^2+4^2}} [((n+2)+ \\ & \sqrt{(n-2)^2-4})^n - ((n+2)-\sqrt{(n+2)^2-4})^n] \\ & = \frac{(n-1)}{n2^{2n} \sqrt{(n^2-4)((n+2)^2-4)}} \\ & \quad \times [(n+\sqrt{n^2-4})^n - (n-\sqrt{n^2-4})^n] \\ & \quad \times [((n+2)+\sqrt{(n-2)^2-4})^n - ((n+2)-\sqrt{(n+2)^2-4})^n] \end{aligned}$$

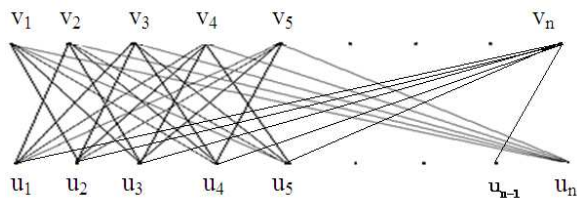


Fig. 2: Corwn graph with 2n-vertices

Complexity of crown graph: A crown graph on 2n vertices is an undirected graph with two sets of vertices u_i and v_i and with an edge from u_i to v_j whenever $i \neq j$. The crown graph can be viewed as a complete bipartite graph from which the edges of a perfect matching have been removed, Biggs (1993) Fig. 2.

Lemma 2.2: Let $D_n(x)$ be $n \times n$ matrix such that:

$$D_n(x) = \begin{pmatrix} x & 1 & 1 & \dots & \dots & 1 \\ 1 & x & 1 & \ddots & & \vdots \\ 1 & \ddots & \ddots & 1 & \ddots & \vdots \\ \vdots & \ddots & \ddots & \ddots & \ddots & 1 \\ \vdots & & & & & x & 1 \\ 1 & \dots & \dots & 1 & 1 & x \end{pmatrix}$$

Then we obtain:

$$\det(D_n) = (x+n-1)(x-1)^{n-1}$$

Proof: From the definition of the circulant determinants, we have:

$$\begin{aligned} \det(D_n(x)) &= \det \begin{pmatrix} x & 1 & 1 & \dots & \dots & 1 \\ 1 & x & 1 & \ddots & & \vdots \\ 1 & \ddots & \ddots & 1 & \ddots & \vdots \\ \vdots & \ddots & \ddots & \ddots & \ddots & 1 \\ \vdots & & & & & x & 1 \\ 1 & \dots & \dots & 1 & 1 & x \end{pmatrix} \\ &= \prod_{j=1}^n (x + \omega_j + \omega_j^2 + \omega_j^3 + \dots + \omega_j^{n-1}) \\ &= (x+1+1+\dots+1) \times \\ & \quad \prod_{j=1, \omega_j \neq 1}^n (x + \omega_j + \omega_j^2 + \omega_j^3 + \dots + \omega_j^{n-1}) \\ &= (x+n-1) \times (x-1)^{n-1}. \end{aligned}$$

Theorem 2.3: Let G be a crown graph with 2n vertices. Then the number of spanning trees of G is:

$$\tau(G) = n^{n-2} (n-1)(n-2)^{n-1}$$

Proof: Applying lemmas 1.2 and 1.5 we have:

$$\begin{aligned} \tau(G) &= \frac{1}{(2n)^2} \det(2nI - \bar{D} + \bar{A}) \\ &= \frac{1}{(2n)^2} \det \begin{pmatrix} n & 1 & \dots & 1 & & & & & & \\ 1 & \ddots & & \vdots & & & & & & I \\ & & & \ddots & 1 & & & & & \\ & & & & & & & & & \\ 1 & \dots & 1 & n & & & & & & \\ & & & & & n & 1 & \dots & 1 & \\ & & & & & 1 & \ddots & & \vdots & \\ & & & & & & & & \ddots & 1 \\ I & & & & & \vdots & \ddots & \ddots & & \\ & & & & & 1 & \dots & 1 & n & \end{pmatrix} \\ &= \frac{1}{(2n)^2} \det \begin{pmatrix} n+1 & 1 & 1 & \dots & 1 \\ 1 & n+1 & 1 & \ddots & \vdots \\ 1 & 1 & \ddots & \ddots & 1 \\ \vdots & \ddots & \ddots & n+1 & 1 \\ 1 & \dots & 1 & 1 & n+1 \end{pmatrix} \end{aligned}$$

$$\times \det \begin{pmatrix} n-1 & 1 & 1 & \dots & 1 \\ 1 & n-1 & 1 & \ddots & \vdots \\ 1 & 1 & \ddots & \ddots & 1 \\ \vdots & \ddots & \ddots & n-1 & 1 \\ 1 & \dots & 1 & 1 & n-1 \end{pmatrix}$$

Applying lemma 2.2 with $x = n+1$ and $n-1$ respectively, we have:

$$\begin{aligned} \tau(G) &= \frac{1}{(2n)^2} \times 2n^n \times 2(n-1)(n-2)^{n-1} \\ &= n^{n-2}(n-1)(n-2)^{n-1} \end{aligned}$$

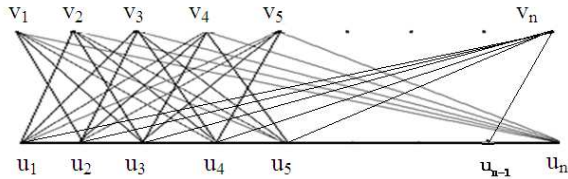


Fig. 3: Open cocktail party graph with $2n$ -vertices

Complexity of open cocktail party graphs: The open cocktail party graph of order n , is the graph consisting of cocktail party graph by deleting $n-1$ edges from one of their rows Fig. 3.

Lemma 2.4: If A and B are symmetric matrices and

$$C = \begin{pmatrix} A & I \\ I & B \end{pmatrix}.$$

Then:

$$\det(C) = \det(AB - I) = \det(BA - I)$$

Proof: Applying the fact that used in lemma 1.5.

Theorem 2.5: Let G be an open cocktail party graph with $2n$ vertices, $n \geq 3$. Its complexity will be:

$$\begin{aligned} \tau(G) &= \frac{(n-1)^n}{n} U_{n-1} \left(\frac{n^2-2}{2(n-1)} \right) \\ &= \frac{n-1}{n \times 2^n \sqrt{n^4-8n^2+8n}} \times [(n^2-2 + \sqrt{n^4-8n^2+8n})^n - \\ &\quad (n^2-2 - \sqrt{n^4-8n^2+8n})^n] \end{aligned}$$

Proof: Applying lemmas (1.2), (1.4) and (2.4) we have:

$$\tau(G) = \frac{1}{(2n)^2} \det(2nI - \bar{D} + \bar{A})$$

$$\begin{aligned} &= \frac{1}{(2n)^2} \det \begin{pmatrix} n & 1 & 1 & \dots & 1 \\ 1 & n & 1 & \ddots & \vdots \\ 1 & 1 & \ddots & \ddots & 1 \\ \vdots & \ddots & \ddots & n & 1 \\ 1 & \dots & 1 & 1 & n \end{pmatrix} \\ &= \frac{1}{(2n)^2} \det \begin{pmatrix} n+1 & 0 & 1 & \dots & 1 \\ 0 & n+2 & 0 & \ddots & \vdots \\ I & 1 & 0 & \ddots & 1 \\ \vdots & \vdots & \ddots & n+2 & 0 \\ 1 & \dots & 1 & 0 & n+1 \end{pmatrix} \\ &= \frac{1}{(2n)^2} \det \begin{pmatrix} (n^2+2n-3) & 2n-1 & 3n-2 & \dots & \dots & 3n-2 \\ 2n-1 & (n^2+3n-4) & 2n-1 & 3n-2 & \dots & \vdots \\ 3n-2 & 2n-1 & \ddots & 2n-1 & 3n-2 & \vdots \\ \vdots & \ddots & \ddots & \ddots & \ddots & 3n-2 \\ \vdots & \dots & \ddots & \ddots & (n^2+3n-4) & 2n-1 \\ 3n-2 & \dots & \dots & 3n-2 & 2n-1 & (n^2+2n-3) \end{pmatrix} \\ &= \frac{(n-1)^n}{(2n)^2} \det \begin{pmatrix} n+3 & \frac{2n-1}{n-1} & \frac{3n-2}{n-1} & \dots & \dots & \frac{3n-2}{n-1} \\ \frac{2n-1}{n-1} & n+4 & \frac{2n-1}{n-1} & \frac{3n-2}{n-1} & \dots & \vdots \\ \frac{3n-2}{n-1} & \frac{2n-1}{n-1} & \ddots & \frac{2n-1}{n-1} & \frac{3n-2}{n-1} & \vdots \\ \vdots & \ddots & \ddots & \ddots & \ddots & \frac{3n-2}{n-1} \\ \vdots & \dots & \ddots & \ddots & n+4 & \frac{2n-1}{n-1} \\ \frac{3n-2}{n-1} & \dots & \dots & \frac{3n-2}{n-1} & \frac{2n-1}{n-1} & n+3 \end{pmatrix} \end{aligned}$$

Straight forward induction by using properties of determinants.

We obtain:

$$\begin{aligned} \tau(G) &= \frac{(n-1)^{n+1}}{(2n-3)n^2} \times \det \\ &\begin{pmatrix} \frac{n^2-2}{n-1} & 0 & 1 & \dots & \dots & 1 \\ 0 & (\frac{n^2-2}{n-1}+1) & 0 & 1 & \dots & \vdots \\ 1 & 0 & \ddots & 0 & 1 & \vdots \\ \vdots & \ddots & \ddots & \ddots & \ddots & 1 \\ \vdots & \dots & \ddots & \ddots & (\frac{n^2-2}{n-1}+1) & 0 \\ 1 & \dots & \dots & 1 & 0 & \frac{n^2-2}{n-1} \end{pmatrix} \end{aligned}$$

$$\begin{aligned}
 &= \frac{(n-1)^{n+1}}{(2n-3)n^2} \times \frac{2n-3}{n-2} \times \det \\
 &\left(\begin{array}{cccccc}
 \left(\frac{n^2-2}{n-1}-1\right) & -1 & 0 & \dots & \dots & 0 \\
 -1 & \frac{n^2-2}{n-1} & -1 & 0 & \dots & \vdots \\
 0 & -1 & \ddots & -1 & 0 & \vdots \\
 \vdots & \ddots & \ddots & \ddots & \ddots & 0 \\
 \vdots & \dots & \ddots & \ddots & \frac{n^2-2}{n-1} & -1 \\
 0 & \dots & \dots & 0 & -1 & \left(\frac{n^2-2}{n-1}-1\right)
 \end{array} \right) \\
 &= \frac{(n-1)^{n+1}}{(n-2)n^2} \times \left(\frac{n^2-2}{n-1}-2\right) \times U_{n-1}\left(\frac{n^2-2}{2(n-1)}\right) \\
 &= \frac{(n-1)^n}{n} \times U_{n-1}\left(\frac{n^2-2}{2(n-1)}\right) \\
 &= \frac{n-1}{n \times 2^n \sqrt{n^4-8n^2+8n}} \left[(n^2-2 + \sqrt{n^4-8n^2+8n})^n \right. \\
 &\quad \left. - (n^2-2 - \sqrt{n^4-8n^2+8n})^n \right]
 \end{aligned}$$
